



## LHNC MEETING NOTES: February 4, 2020

Live Healthy Napa County (LHNC) seeks to promote and protect the health and wellbeing of every member of the community by bringing together diverse partners to:

- Develop a shared vision of a healthier Napa County with a focus on health equity and social determinants of health.
  - Create an action agenda to realize that vision
- 

At LHNC's November convening, participants were asked to review both their Open Space Technology (OST) group's notes from August's meeting and the learning conversation feedback to answer these three questions:

- What similar themes, ideas or assets emerge?
- What resources, skills, or time can you bring to this issue?
- Who else needs to be at this table?

OST Groups:

- **New Parents/Pregnant Moms**

In February, LHNC launched the Community Health Action Plan. Using Human-Centered Design, participants selected "How Might We" questions to generate ideas for action items. The "How Might We" questions were created using the notes from the November LHNC meeting, detailed in the link above. LHNC participants used the "Ideation/Creation Expedition" model to brainstorm ideas, focusing on quantity first. Then, each group selected one idea that they felt LHNC should include in the action plan. Groups shared out their ideas, and the reasoning behind them.

Public Health has received two grants to assist with 1) engaging community members who are most impacted by health inequities and 2) create shared data measures with community partners to address Respect & Social Inclusion. One grant, the Cross-sector Innovations Initiative (CSII), was received in partnership with Cope Family Center and Community Health Initiative. This grant will help support the work of LHNC, the Community Leaders Coalition (CLC), and other initiatives working to improve health equity in the county.

An Ad-Hoc committee of LHNC partners convened to review the final draft of the Community Health Improvement Plan. Final edits are underway and the final CHIP will be shared soon!

Next steps for LHNC partners:

- We will reach out to our design groups to finalize proposed action items, and make sure all details have been captured accurately.
- We will send out a survey, asking LHNC partners to prioritize the proposed action items, with a goal of narrowing down our plan to four action items.
- We will work to convene groups around our four action items, and invite our learning conversation participants to join those meetings, in order to further define the action item details.
